5	Photocopy of the purchase orders executed in the last one year in same firm name and style with atleast one performance certificate.		
6	Affidavit regarding any litigation, debarred or blacklisted or history of rescinding work, and the informations furnished in the bidding document is correct		
7	Any document (such as excise/sales tax document) issued by Govt. or Semi Govt. Department which certifies/proves that the bidder is in business for the required period.		

8	The bidder shall be registered with the office of competent authority or under statutory bodies at the time of bid opening in the same name and style. In order to support this, bidder shall submit-		
a.	A copy of the Registration Certificate issued by the Registrar of Companies in case of firms of proprietary nature.

9	Bidder shall enclose/mention the PAN and TAN number of the firm and to support this, he/she shall submit a photocopy of PAN & TAN certificate.		
10	Copy of Balance sheet alongwith profit and loss statement for the last year duly certified by Chartered Accountant to reflect the annual turn over or Bank solvency certificate of Rs 25 lacs.		
11	Bidder's firm shall be registered with Sales Tax Department. GST numbers shall be mentioned by the bidder and in support of this; he/she shall submit a photocopy of GST registration certificate duly renewed by the competent authority.		
12	Submitted documents shall be numbered and attached serially indicating serial number. Total number of pages enclosed shall be shown in the box.		
13	ISO certified company shall be preferred to others. A copy of valid license/ certificate shall be attached to this effect with the offer and tick appropriately.		
14	The officers of COMFED shall be allowed to inspect the works and/or any document referred to in the tender. If it is found that the declarations made by the tenderer in Technical Bid are false/ misleading/faulty, the tenderer shall be disqualified and the earnest money deposit submitted shall be forfeited.
