Bihar State Milk Cooperative Federation Ltd, Patna (COMFED) invites sealed bid for creating reverse logistic and recycling of post-consumer 2500 MT LDPE/LLDPE SINGLE- LAYERED PLASTIC (SLP) Waste through Sustainable Waste Disposal Mechanism in Bihar, Jharkhand, Delhi NCR, North-East States, Northern part of West Bengal etc for one year.

- 4) The offer must be sent in a sealed cover super scribing on the top left-hand corner offer **for creating reverse logistic and recycling of post-consumer 2500 MT LDPE/LLDPE SINGLE - LAYERED PLASTIC (SLP) Waste.**
- 5) Offer received after due date for whatsoever reason will be rejected.
- 6) Offer rate should be valid for acceptance for 90 days.
- 7) The Rate should be as per Annexure – I.
- 8) In case of receiving lowest offer, same shall be reviewed by the management in terms of offer which are incomplete or not meeting the condition/our requirement and may be rejected without assigning any reason.
- 9) Right to reject any or all the offers without assigning any reason thereof is reserved by COMFED.
- 10) Offer which are incomplete or not meeting the conditions /our requirement is liable for rejection.
- 11) Management reserves the rights to accept or reject all/any offers submitted by bidders, without assigning any reasons. In case of any dispute Management decision in these regards would be considered as final and no complaints will be entertained.

12) In case of any query, interested bidders can visit/call COMFED between 2 to 5 PM during enquiry period.

13) Bidder has to pay EMD of Rs. One lakh in form of DD of Nationalised Bank.

### Annexure – I

#### **Background**

Bihar State Milk Cooperative Federation Ltd (COMFED) is an Apex body of its 8 affiliated member milk Unions of Bihar, COMFED also have 7 Milk Processing Units. The member milk unions and COMFED have dairy plants in Bihar, Jharkhand, Delhi-NCR, UP, Assam and other States of India. The member milk Unions and Unitsof COMFED is engaged in marketing of milk and milk products packed in poly pouches, in various States across India under the brand name “SUDHA”.

As per plastic waste management rules 2016, it is responsibility of Producer, Manufacturer and Brand owner to establish a mechanism for disposal of plastic waste generated due to its products i.e. Extended Producers Responsibility (EPR).

COMFED intends to meet its EPR obligation of creating reverse logistic and recycling of LDPE/LLDPE SINGLE- LAYERED PLASTIC (SLP) Waste poly pouches used for packaging fresh milk & fresh products in towns/markets of Bihar and Jharkhand. Offers are invited for establishing the complete mechanism of recycling the post-consumer plastic waste generated due to single layer virgin LDPE film which is 100% recyclable poly pouches. Detailed scope of work shall be as under:

#### **a. Scope of Work**

- Establishing a mechanism for collection of post-consumer waste generated by households through appropriate channel like - waste pickers, waste aggregators, scrap dealers, commercial establishments, SUDHA Retail Point / parlours, road litters etc. and transportation to processing facility through adequate capacity vehicles.
- Sorting and processing of waste at their facility – Recyclable LDPE/LLDPE SINGLE- LAYERED PLASTIC (SLP) Waste poly pouches PE Material.
- The facility must have Central/State Pollution Control Board (CPCB/PCB) consent of adequate capacity at least equivalent to the take back quantity offered by the bidder.
- Dispatch of waste for Recycling in suitable market acceptable forms such as granules/lumps.

- Provide take back credits equivalent to Metric Tons of PE Plastic recycled to COMFED.
- Provide EPR Certificate on monthly basis to COMFED stating quantum of waste diverted from land filling, tons of CO2 emissions mitigated and energy saved which can be submitted to the concern Pollution Control Board.
- Provide a detailed activity report on established channels, Nos. of waste pickers engaged for take back system and quantity of recycling established in state of implementation.
- Creating awareness of consumers for recycling of plastic waste through suitable mass media like advertisements, workshops, hoarding at collection centres etc.
- Mention the COMFED's initiative in different EPR Forums across the country.
- Preparation of Action Plan to meet EPR obligation, assistance for getting endorsement of action plan by concerned Government authority/department and obtaining plastic waste registration for COMFED's Units /member milk unions.

**b. Notes:**

1. Bidder can submit the offer for quantity to be recycled as per their available PCB consent. However, minimum recycling capacity of its own and/or with tie up should be 500 MT/annum. Bidder should latter establish their processing plant in Bihar / Jharkhand in coming years.
2. Bidders should have valid PCB approval and will be responsible for any query related to PCB.
3. Certificate submitted to COMFED must have traceability to actual quantity of post-consumer waste pick up done by agency for COMFED.
4. Bidder shall submit certificate on monthly for recycled quantity as per the liability of COMFED for recycle quantity of PE. COMFED may submit the same to concern PCB and if required PCB may also enquire with agency for the same. Bidder shall be responsible for proper settlement/reply of any query related to recycling of plastic done on behalf of COMFED.

5. Duration of contract shall be one year from the date of issue of order. In case of any non-compliance of any terms & conditions mentioned in the agreement, the either party can terminate the contract by giving two-month advance notice to the other party. Offer should be given on per kg of waste handled basis i.e. INR/kg of waste recycled in Part – II (Financial Bid).
6. In case of dispute about any terms of this deed, same shall be resolved by mutual negotiations between the parties within 15 days of such dispute. If not resolved then it shall be referred to court at Patna which shall have exclusive jurisdiction.
7. Successful bidder shall enter in MOU with COMFED mentioning therein the commitment for quantity of recycling.

**c. Eligibility Criteria:**

- a) The bidder should be in the business of recycling of plastic waste in the same name and style since last one year.
- b) The bidder's must be registered with State / Central Pollution Control Board/other authorities and has its own recycling plant or tie up with recycler for recycling post-consumer waste.
- c) The bidder should be performing EPR function for other FMCG companies in the same name and style satisfactorily and produce evidence of the same while submitting the bid.
- d) The bidder shall furnish a copy of the Income Tax returns and the Income tax clearance certificate for the previous year (s), in certified true copies.
- e) The bidder must submit company's registration certificate.
- f) The bidder should furnish copy of PAN and GST Registration.
- g) The bidder should submit CA certified P/L and B/S or certificate of Annual Turn Over (ATO) which should be minimum Rs. 5 crore in one year during last 3 years.
- h) The bidder should submit latest worthiness certificate of Rs. 1 crore issued from their Banker.
- i) The bidder should submit a DD of Nationalised Bank of Rs. One lakh only as EMD amount in favour of Bihar State Milk Cooperative Federation Ltd payable at Patna, on which no interest will be payable. The EMD amount will be converted into security deposit after allotment of work.
